Abacus Year End Payroll Procedures

Prepare and post the last payroll in December before you print the T4 slips, print the T4 summary report for Revenue Canada.

Special Note: Canada Revenue Agency (CRA) requires that you to upload all your T4 data to their web site electronically, if you have 50 or more employees. There will be major penalties imposed upon you if this is not done. Note: To create the Electronic XML file for upload, will required that you have Abacus 32 Windows V6.00.

To accommodate the new XML file upload, ALL of the current employees MUST be edited and the names and addresses need to be adjusted.

An employee initial has been added. The address needs to be adjusted to separate the City and Province from the address lines

Adjust the employee records before you perform the T4 functions.

Make sure you have performed a backup of all the data locations you are going to update. Make sure you have a backup BEFORE you reset the employee files for the new year.

Do not post any of the new-year payroll batches before you print the T4 slips. When you run FUNC WCRE, it resets the year-to-date fields to zero in all the employee master records. If you post the new year payroll batches before you print the T4 slips, FUNC WCRE will delete all the employee year-to-date totals for the New Year.

If you installed the ABACUS system after January 1, keep in mind that the reconciliation report only shows the calculated totals of the payroll transactions posted in the system. **If you manually entered year-to-date totals in most employee records after installation, the report cannot reconcile those employees.** However, the discrepancies should equal the manually entered amounts. If you re-created each payroll record from January 1 to the day you started using the installed system, the employee records should reconcile.

To prepare the employee payroll for the New Year:

- Print the *Employee Reconciliation Report* using option "P" in FUNC WCRE. This provides details of the discrepancies between the year-to-date totals in the employee master records and the sum of the detail records in the payroll sub-ledger. Always print this report as a part of the T4 Audit process.

- Reconcile the year-to-date totals in the employee master file with the payroll ledger. If you used ABACUS for the entire calendar year, select option "R" in FUNC WCRE to do this automatically. To save time, only reconcile the ranges of employees with discrepancies on the reconciliation report.

- Print the T4s on the forms provided by Revenue Canada, or print the T4tlat-09b.pdf available on our web site. Remember when printing the T4 pdf file, to turn the scaling to "None". The T4 Print Procedures have been enhanced to allow the entry/correction of information on the T4 forms. Please read the following pages on the procedures for running T4's.

- Print the information for the T4-T4A Summary of Remuneration Paid form provided by Revenue

Canada. Please read the following pages on the procedures for running the T4 Summary.

- Once you are certain that the T4 slips are correct and have all the information required, reset the yearto-date totals in the employee master records. Use option "E" in FUNC WCRE to do this automatically. This step is irreversible. The payroll sub-ledger is also purged at this time.

- ABACUS stores the UIC insurable earnings from the last 53 weeks in the year for Record of Employment (ROE) purposes. FUNC WCRT uses these values for the termination slips that you might need to print in the first 53 weeks of the New Year.

- Update the TD1 information.

Important: After you have installed the Abacus payroll update for 2024 and you wish to run either the T4 or Year End Functions for the Wage Module please ensure that you enter the Abacus program using a January 1, 2024 date and not a 2023 date. If you use a date for 2023, you will receive a message of "Invalid Date for this release"

Editing The Employees

Under WCE – Employee Edit, you will need to edit each employee and correct the name and address information, to separate the initial from the first name and the City and Province from the address information.
